

# Alaska Long Board Surf Festival August 7-11, 2002

## ACCIDENT WAIVER AND RELEASE OF LIABILITY

I am a registered participant in the Alaska Long Board Surf Festival to be held August 7-11, 2002. I realize this is activity involving bush plane travel, surfing in the ocean with tides, winds and marine hazards (animate and inanimate) of all types, and land hazards (animate and inanimate) of all types. I fully realize that events of this nature will entail a great deal of risk to me, both serious injury and even death. I also realize that this event could not be held unless I am willing to assume all consequences of these risks. Therefore I assume full responsibility to inform myself as to all the dangers and risks and I sign this **Accident Waiver and Release of Liability** as a legally binding method of personally assuming all of these risks. In consideration of my entry I agree to execute this **Accident Waiver and Release of Liability**.

I acknowledge that events in the Alaska Long Board Surf Festival can be an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to those caused by terrain, facilities, temperature, weather, personal conditioning, plane travel, fellow surfers' surfboards, water animals, land animals (bears), and other producers of the event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, because of their possible liability without fault.

I have read the information sheet for the Alaska Long Board Surf Festival and agree to comply with all listed information pertaining to the event.

I understand that no medical care is available at the event site and that due to bad weather or incident arriving from communication failure medical attention could possibly be delayed for several days.

I acknowledge that this **Accident Waiver and Release of Liability form** will be used by the event holders, organizers in which I may participate and that it will govern my actions and responsibilities at said event.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, release and discharge from any and all liability for my death, disability, personal injury, property damage or actions of any kind which may hereafter accrue to me including traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: Event sponsors, Barges Surf Club, event directors, volunteers, event employees, event holders; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this event, whether caused by negligence of releases or otherwise.

This **Accident Waiver and Release of Liability form** shall be constructed broadly to provide a release and waiver to the maximum extent of the law.
